CONGRESSMAN PETER WELCH

Candidate for U.S. House of Representatives

LIEUTENANT GOVERNOR PHIL SCOTT

SECRETARY OF STATE JIM CONDOS

Candidate for Secretary of State

AUDITOR DOUG HOFFER

Candidate for Auditor of Accounts



As the author of the Job Gap Study (a series of reports from 1997 to 2010), Doug Hoffer provided policy guidance for Legislators dealing with economic development and related tax policies, the livable wage, and the benefits of greater in-state purchasing.

Hoffer pledged more transparency and more accountability. Today, the State Auditor's website has more details about the budget, the contract with KPMG, as well as an improved strategic plan and performance report. Also, fear of retaliation has prevented many state employees from reporting waste, fraud, and abuse in state government. In order to encourage whistleblowers to come forward, Hoffer decided to create a safe place for them and persuaded the legislature to support a new law protecting their identities.

Hoffer believes that tracking the money raised and spent by state government is important but it is just the beginning of the Auditor's job, not the end.

ATTORNEY GENERAL WILLIAM SORRELL



Bill Sorrell has earned a reputation as one of Vermont's most dedicated and effective public servants. When you look at Sorrell's record, it's no wonder Vermonters have decided — seven times — to send him back to Montpelier to keep up the fight for Vermont.

He believes the Office of Attorney General is among the most important elected positions in Vermont or any state. With a responsibility to seek justice for all, integrity, energy and competence of the Attorney General are key to the security of our citizens and their confidence in the fairness of the enforcement of our laws.

The Attorney General wears two hats: to represent the interests of the government in a wide range of court proceedings and to represent the general welfare of all the people. When these two interests are in conflict, the Attorney General must strive to see that both interests are protected and well-represented.

IMPORTANT INFORMATION FOR VERMONT VOTERS

• Call your town or city clerk where you live to find out where your polling place is in your community.

• All polls open between 5 a.m. and 10 a.m., depending on the town. All polling places close at 7 p.m. You should contact your town clerk to find out when your polling place opens.

• In Vermont, if you registered to vote when you renewed your driver's license, or as part of a voter registration drive, you will not be required to show ID. Only first time voters who have registered by mail have to show ID in order to vote.
