Our Endorsed New Hampshire Candidates

SENATOR JEANNE SHAHEEN

Candidate for U.S. Senate



United States Senator Jeanne Shaheen is the only woman in American history to have been elected Governor and U.S. Senator, with a record of breaking partisan gridlock to make a difference for the people of New Hampshire.

As Governor, Shaheen's focus on the economy helped New Hampshire businesses create nearly 67,000 new jobs. As a member of the U.S. Senate Small Business Committee, she helped craft the Small Businesses Jobs Act, which provided small businesses with tax breaks and access to the credit they need to grow and create jobs. Senator Shaheen is a leader in increasing export assistance to New Hampshire small businesses so they can sell their goods and services around the world.

Shaheen is a strong supporter of equal pay for equal work, voting for the Lily Ledbetter Fair Pay Act and cosponsoring the Paycheck Fairness Act. She also fights to make sure that small businesses can compete for federal research grants. As Senator, she is working to expand opportunities for small businesses to export and sell their products and services to growing markets around the globe. Shaheen helped craft the Small Business Jobs Act that included tax cuts for small businesses and boosted access to credit through SBA lending programs. She fought for the creation of the Manchester Job Corps Center and is a leading advocate for attracting students to careers in science, technology, engineering and math (STEM) to be prepared for the jobs of the future.

CONGRESSWOMAN CAROL SHEA-PORTER

Candidate for U.S. House of Representatives **District 1**



Carol Shea-Porter, the first woman ever elected to national office from New Hampshire, served two terms in the U.S. House of Representatives, from 2007 to 2011, and is once again serving New Hampshire's 1st Congressional District in the 113th Congress. She serves as a member of the House Armed Services Committee (Subcommittees on Readiness and on Military Personnel) and the Natural Resources Committee (Subcommittees on Fisheries, Wildlife, Oceans & Insular Affairs and on Public Lands and Environmental Regulation).

Shea-Porter is a strong advocate for issues that are important to women and families. She was an original cosponsor of H.R.11, the Lilly Ledbetter Fair Pay Act of 2009, which

became law on Jan. 29, 2009, and was also an original cosponsor of the Paycheck Fairness Act, which would have amended the Equal Pay Act to revise remedies for, enforcement of, and exceptions to prohibitions against sex discrimination in wages.

Her top priority is creating good jobs for New Hampshire working families, and she has held roundtables with business owners and employment information sessions for veterans across the state. New Hampshire small businesses and workers are the backbone of the state's economy, and she is working for smarter investments in job creation, research and development, and infrastructure to help power the state's growth.

CONGRESSWOMAN ANN MCLANE KUSTER

Candidate for U.S. House of Representatives District 2



Ann McLane Kuster was elected to the United States Congress to represent New Hampshire's 2nd District in November 2012, and was sworn into office on January 3, 2013. She is the first woman to ever represent the district in Congress. She is a member of the House Committee on Veterans' Affairs, the House Committee on Agriculture, and the House Small Business Committee.

Her top priority in Congress is to help create jobs and opportunity for hard-working middle class New Hampshire families. While our nation's small businesses drive job creation and economic growth, our government plays a critical role in fostering the conditions businesses need to grow, thrive, and create jobs. As a member of the Small

Business Committee, she is actively working to support innovation and the expansion of economic opportunity in our country.

McLane Kuster believes that our roads, bridges, airports, electrical grid, and other components of our national infrastructure are the foundation on which our economy is built. For American businesses to expand and hire, we must repair and strengthen the shared infrastructure needed to transport goods, people, and power. That is why she is a cosponsor of the Partnership to Build America Act (H.R. 2084), bipartisan legislation to leverage private investments to fund an Infrastructure Bank for financing public works projects.

GOVERNOR MAGGIE HASSAN

Candidate for Governor of the State of New Hampshire



Governor Maggie Hassan is moving New Hampshire in the right direction and solving problems the New Hampshire Way – bringing people together and working with Independents, Republicans, and Democrats to build a stronger middle class and a brighter economic future for New Hampshire.

COUNCILOR COLIN VAN OSTERN

Candidate for Executive Council - District 2

ROBIN MCLANE

IMPORTANT INFORMATION FOR NEW HAMPSHIRE VOTERS

- 1. Absentee Ballot Search If you applied for an absentee ballot, you can find out if the clerk has received your request; when the absentee ballot was sent to you; and when it was received back in the clerk's office.
- 2. Party Information If you are not sure what party you are registered as on the checklist, you can check it by going to sos.nh.gov.
- 3. Polling Place Search Find out where your polling place is in your town or ward for state elections.
- 4. Clerk Information Search Find out who your clerk is and where the town office is located.
- 5. State List Clerks and Polling Places You can download a list of all town clerks and their contact information, as well as where the polling places are across the state with the hours of polling. *Please note: the polling places and hours of polling are for state elections only not local elections.

Remember the Voter ID Law is now in effect in New Hampshire!

YOU WILL NEED TO BRING.....

- Driver's license issued by any state (even if expired)
- ID card issued by NH DMV (Division of Motor Vehicles)
- U.S. Armed Services ID card
- U.S. Passport (even if expired)
- Valid photo ID card issued by either the federal government or a state, county or municipal government
- Valid student ID card

• Other photo ID deemed legitimate by the supervisors of the checklist, the moderator, or the clerk or verification of identity by a supervisor of the checklist, the moderator or the clerk.

A voter who does not have an approved photo ID may obtain a free photo ID for voting purposes only by presenting a voucher from their town/city clerk or the Secretary of State to any NH DMV office that issues identification.
