Adhere to preventative maintenance schedules and servicing requirements on real property installed equipment; assists others performing general maintenance requirements as necessary to support the mission of the 168th Air Refueling Wing of Alaska Air National Guard and DMVA. Works under the direction of the Facility Management Division Foreman and generally has the authority to make decisions necessary to complete assigned tasks in a safe and efficient manner.

Maintain, inspect, repair, adjust and install complete electrical systems in a timely and professional manner Troubleshoot and repair defective electrical equipment and proper grounding of conduits Recognize and respond to dangerous situations or emergencies such as high voltage systems, electrical fires, loose hot wires, broken power lines, etc. and use appropriate response equipment to correct/control the situation.

Adhere to work schedules, quality standards, safety and security rules and regulations Occasionally perform semi-skilled maintenance work as a maintenance generalist Operate snow removal equipment during winter months and may perform grounds maintenance when required.

Must be able and willing to travel out of state and within state by various modes of transportation, e.g. snow machine, small aircraft, boat, ATV and/or other available means.

Must be willing and able to overnight in a camping environment e.g. sleeping bag on floors with minimal amenities.
